National Park Service Chisolm and Western National Historic Trails Designation Policy Briefing

When: Thursday, September 10, 2020, 10:00 – 11:00 a.m. Central Time.

<u>Who Should Attend</u>: Affected KNRC members, and invited non-member county commissioners; the Kansas Congressional Delegation; administrative agency personnel; and, congressman/staff from the Congressional Western Caucus.

Registration: Registration is required; a webinar link will be sent to participants.

In 2009, Congress directed the Secretary of the Interior to evaluate potential designation of the Chisolm and Western Trails as national historic trails (NHTs) under the National Trails System Act.¹ The National Park Service (NPS) has completed a feasibility study and issued a finding of no significant impact (FONSI), concluding both trails meet federal criteria for potential, National Historic Trail designations.

The NHT designation process requires Congressional approval, which would then be followed by preparation of a Comprehensive Plan (CP) by the Department of the Interior and other, executive branch agencies. Legislation has been prepared by Kansas Senator Jerry Moran which would designate the Chisolm and Western National Historic Trails and appropriate funding for the process. As of August 24, 2020, that legislation has not been introduced for consideration by the Congress.

KNRC has conducted a detailed policy and statutory review of the impacts that the proposed Chisolm and Western trails could have KNRC member counties, the environment, and private landowners.

This policy briefing webinar will summarize the status of the designation process, present detailed maps of select counties affected by the trails and propose policy positions and issues for discussion by member and non-member counties.




FIGURE 7. PROPOSED CHISHOLM NATIONAL HISTORIC TRAIL AND WESTERN NATIONAL HISTORIC TRAIL STUDY ROUTES - MAP 5 (OKLAHOMA AND KANSAS)




FIGURE 8. PROPOSED CHISHOLM NATIONAL HISTORIC TRAIL AND WESTERN NATIONAL HISTORIC TRAIL STUDY ROUTES - MAP 6 (KANSAS AND NEBRASKA)
